# Membership

Use of the Stonegate Village Metropolitan District and Lincoln Park Metropolitan District's swim and tennis facilities are available to residents of the District. A "resident" is defined as someone residing within the borders of the Stonegate Village Metropolitan District or Lincoln Park Metropolitan District and whose water bill reflects an assessment of the *Stonegate Village Metropolitan District*. Residents who occupy a rental property or multifamily dwelling must provide proof of residency (water bill and/or government issued ID). **All residents MUST present valid membership cards to the gate monitor when entering the facility. Residents MUST also sign in upon entering the facility. Individuals who do not present a valid membership card will be denied entry to the facility. Parents/Guardians may sign in for children.**

## MEMBERSHIP CARDS:

- The District utilizes an electronic ID system and membership cards will be valid every year.
- A Pool Identification Card is necessary to enter the pool area. ID cards are issued to each person in the household 10 years and older.
- Before entering the pool area, residents MUST SHOW THEIR ID CARD AND SIGN IN WITH THE LIFEGUARDS
- Replacement Membership Cards are available at the front desk for a fee of five dollars.

## GUESTS:

Use of the recreational facilities is a privilege afforded to residents. The facility is also available for use to resident's guests. Guests may be admitted only if ***accompanied*** by a resident. The resident is responsible for any fees and all conduct of their guests. A resident may not have more than six (6) guests at any one time (except for paid parties as described later). Each family is entitled to ten (10) guest passes free of charge.

Additional guest passes may be purchased ***only*** by providing a check payable to the *Stonegate Village Metropolitan District*. The guest passes are available in increments of (10) for \$30.00 per card.

Additional guest passes may be purchased by filling out a form available at the pool front desk and expire at the end of the season.

**The procedure for admitting guests is as follows:** Member must accompany guests for the entire time they use the facility. The guest(s) will be asked to sign in and the gate monitor will digitally record each guest entering the facility. The guest pass is good all day, however, if the guest leaves, they must sign-in again when they return.

# Rules and Regulations

## **SWIMMING POOL RULES:**

***Membership cards are required for admission to the pool. Cards must be presented to the gate monitor to enter. No exceptions.*** The Stonegate Village and Lincoln Park Metropolitan District has an agreement with Front Range Recreation, a professional pool management company, for the use of the swimming pools and swimming instruction.

## **POOL RULES**

1. No pushing or dunking.
2. No spitting or throwing of water.
3. No running.
4. NO GLASS CONTAINERS.
5. Do not restrict flow of water from spray features.
6. Do not sit on the spray features.
7. No diving in shallow areas.
8. No hanging on life lines or diving board.
9. No conduct detrimental to safety.
10. Obey the lifeguards at all times.
11. No unnecessary conversation with the lifeguards.
12. NO MERMAID TAILS.

## **REGULATIONS**

1. The lifeguards have complete control over all activities in the pool area, and their instructions must be obeyed.
2. Unsafe behavior could result in the offender being asked to leave the pool area for the rest of the day. Pool privileges may be suspended for up to 48 hours by the lifeguards and for longer periods by the pool manager or Board of Directors, for infractions of pool rules and/or regulations.
3. Food is not permitted in or near the swimming pools. Trash must be disposed of in waste receptacles.
4. Children not toilet trained must wear a swim diaper while in the pools. No plastic diapers are permitted in the pools.
5. Small floating toys, rafts, rings, tubes or boards are allowed in the shallow end of the pool if not detrimental to safety and may be prohibited at the discretion of the lifeguards. ANY INFANT, TODDLER OR CHILD UNABLE TO SWIM MUST BE IN DIRECT CONTACT WITH AN ADULT IN THE WATER WHEN USING FLOTATION DEVICES. Large rafts, boats, etc. are not allowed in the pool at any time. Hard balls, such as tennis balls, may not be brought into the pool area.
6. Children under 10 must be accompanied by an adult or responsible baby-sitter 16 years or older. If the lifeguard determines the baby-sitter is not supervising the child satisfactorily, both will be asked to leave.
7. Animals are not allowed in the pool area or to be left tethered unattended at any time.
8. During regular pool hours, the pool will be cleared every hour for a 10 minute period. Adults 18 and over ONLY will be permitted to swim. An adult may take one non-swimming child 3 years or under into the water, but must remain in DIRECT CONTACT with the child. No children are allowed in the lap lanes during adult swim.
9. Proper swimming attire is required - swim suits only. No cutoffs may be worn into the pool.
10. Foul, abusive or excessively loud language will not be permitted.

11. All users of the pool shall be responsible for damage to property of the District caused by their family and/or guests.
12. Radios must be played so as not to be offensive to others. The lifeguards will determine acceptable volume levels. Failure to comply will result in loss of playing privileges.
13. Bicycles, skate boards, scooters, etc. are not allowed in the pool area. Roller blades must be removed before entering the pool area.
14. No person having an infectious or communicable disease or open wound is permitted in the pool.
15. Smoking, Vaping and/or tobacco products are not permitted in the pool area.

#### **DIVING BOARD**

1. Only one person on the diving board at a time.
2. Only one bounce is allowed.
3. After going off the board, swim directly to the side and exit using the ladders.
4. Do not swim under the diving board.
5. Do not hang on the diving board.
6. No catching divers.

#### **LARGE GREEN SLIDE**

1. Swimmer must be at least 48" tall.
2. Only one person on the slide at a time swimmer at the top must wait until the swimmer before them exits the pool.
3. Swimmer must go down the slide feet first.
4. No stopping or standing on the slide.
5. Immediately after going down the slide, swimmer must exit the pool to the west.
6. Do not swim under the slide.
7. Do not hang on the slide.
8. No shoes, shirts, cutoffs or goggles.

#### **SMALL GREY SLIDE**

1. Swimmer must be able to swim.
2. Only one person on the slide at a time swimmer at the top must wait until the swimmer before them exits the pool.
3. Swimmer must go down the slide feet first.
4. No stopping or standing on the slide.
5. Immediately after going down the slide, swimmer must exit the pool to the north.
6. No one is allowed in the roped area
7. No catching swimmers
8. Do not swim under the slide.
9. Do not hang on the slide.
10. No shoes, shirts, cutoffs or goggles.

#### **BABY POOL**

1. The baby pool is for use by children 6 years and under ONLY.
2. PARENTS ARE RESPONSIBLE AND REQUIRED TO SUPERVISE CHILDREN USING THE BABY POOL.

***Additional rules and regulations may be added at any time without notice at the discretion of the Stonegate Village Board of Directors.***

### **SWIM LESSONS:**

Front Range Recreation uses the nationally recognized Swim Lesson University© Curriculum to help students grow as swimmers and learn to be safe in the water. Class sizes are small with a maximum of 4 students per instructor. Our lesson goal is to give students the skills to be safe and enjoy swimming for a lifetime.

## **Parties and Facility Rentals**

### **DAY PARTIES:**

During the daily operation of the facility, members may host small gatherings of **no more than fifteen (15) people** by phoning the appropriate facility and making a reservation through Front Range Recreation. Guest passes must be used for any such gathering. If additional lifeguards are needed, the party host is responsible for lifeguard fees of \$35 per hour per guard. Reservations must be made at least two weeks in advance. Please observe the party limit for safety reasons and so that other members' usage is not compromised. Other than identified here, the Pool area cannot be blocked for private parties during normal daily operations. Failure to comply may result in removal of the party from the pool and forfeiture of memberships.

### **EVENING PARTIES:**

Any adult member (21 or older) may rent the facility for evening functions subject to pre-payment of the rental fee (\$25) and provision of a signed Contract and Facility Use Agreement. Reservations must be made no less than two weeks in advance of the activity and may be made six months in advance on a first come, first served basis. Additional lifeguard fees apply based on total projected attendance at \$35 per hour per guard, with a minimum of two (2) lifeguards.

### **GENERAL GUIDELINES FOR ALL PARTIES:**

*(Please refer a/so to the Contract and Use Agreement which contains more specifics.)*

1. A minimum of two lifeguards for two hours is required in order to rent the facility. One lifeguard is required for every additional (30) people. The lifeguard fee is \$25.00/hour per lifeguard. Lifeguard hourly fee is subject to change at any time without prior notice. There is a required security deposit of \$100.00.
2. The Board or Pool Management Company may use its discretion to increase the number of lifeguards required, or raise the security deposit, depending upon the type of function for which the facility is being used.
3. Evening parties may begin at 6:00 p.m. Monday through Thursday and parties must end by 10:00 p.m. (music turned off and clean up to begin at 9:30 p.m.). On Friday and Saturday parties must end by 11 :00 p.m. (music turned off and clean up to begin at 10:30 p.m.) Set-up may not begin prior to 5:30 p.m. Please note that the hours between 6:00 p.m. and 8:00 p.m. the pool is open for general use. Please be respectful of other members and their use of the pool until normal closing hours. Please do not move any tables prior to closing.
4. Adult members must be present at the function.
